Sub: Application for Letter of Permission for functioning of Sayali Charitable Trust, College of Homoeopathy, Gut No. 141, 150, 55 Mitmita, Nashik Road, Aurangabad for 100 seats in Undergraduate (BHMS) course for academic year 2023 - 24: reg.

Sir/Madam,


Sayali Charitable Trust, College of Homoeopathy, Nashik Road, Aurangabad is functional since 2017 has submitted an application for permission for sanction of 100 seats in Undergraduate (BHMS) course for the academic year 2023-24. The College has submitted the Part I information in which the entire functional profile has been narrated. Medical Assessment and Rating Board for Homoeopathy (MARBH) has examined the profile of the College as to whether the college fulfils the Minimum Essential Standards to be fulfilled as per the prevailing regulations under NCH Act 2020. The College is directed to maintain the essential standards to impart quality education in Homoeopathy and maintain the following measures in the Collegiate Hospital:

(a) For College:

- In Part-I, the designation of Dr. Uma Purushottam Kulkarni Dept. of Physiology is mentioned as 'Doctor'. Documents such as appointment letter, joining, affidavit and attendance of Dr Uma shall be submitted for verification. Engagement of 'Doctor' cannot be accepted. Appointment of faculty in Dept. of Physiology shall be completed and submit the documents such as qualification and experience for verification.
- Faculties appointed in Dept. of Surgery along with the documents such as qualification, appointment letter, attendance and affidavit shall be submitted for verification.
- Computerized Central Registration for OPD attendance last 01 year shall be submitted for verification.
- Form 16 for all staff from Traces Portal shall be submitted for verification.

(b) For Hospital:

- Attendance of students undergone training in MOU Hospital shall be submitted for verification.
- Biometric Attendance of Hospital Staff: Not submitted. Aadhar enabled biometric attendance system for College and Hospital shall be installed in the College showing timings of 'arrival' and 'departure' and data for 03 months shall be submitted.
- Case records should be maintained with demographic details of the patient such as name, age sex, address, phone number with complete case analysis, evaluation and repertorisation. These documents and follow up attendance of patients shall be made available in the medical record room for academic purposes of students.
- Lab investigation reports should be maintained properly in case records.
- Disease diagnosis shall be recorded in all case records as per ICD 11 criteria.

The above shortfalls observed in the College shall be rectified within a period of 15 days or before the first day of counselling for admissions whichever is earlier. Failing which the conditional permission issued will be withdrawn without further notice.

Considering the facilities available with the College, MARBH has decided to issue **conditional permission to Sayali Charitable Trust, College of Homoeopathy, Gut No. 141, 150, 55 Mitmita, Nashik Road, Aurangabad, Maharashtra for 100 seats in Undergraduate (BHMS) course for academic year 2023 – 24.**

It is further informed that minimum 15% of undergraduate seats of the permitted intake capacity of 100 UG seats shall be treated as All India Quota. The counseling for seats under All India Quota shall be conducted by respective counseling authority of State/UT Govt. as designated by Central Government/NCH for the A.Y. 2023-24 and counseling for the remaining 85% seats or as the case may be, shall be conducted by the concerned Counseling Authority of that State/UT. The permission of the college stands withdrawn if the college fails to comply with the aforesaid direction of the Central Government/NCH for All India Quota or the students admitted thereunder.

All admissions shall be made from NEET qualified candidates only. The permission of the college stands withdrawn if the college fails to comply with the aforesaid direction of the Central Govt. for All India Quota or the student admitted thereunder. The category wise list of the selected candidates may be informed to the MARBH after the process of admission is completed. Any admissions carried out other than NEET qualified students will not be approved by MARBH.


